

1. This modification incorporates the infrastructure upgrade effort necessary to provide telephone firewall capability as referenced in the Contractor's proposal dated July 31, 2002, and as amended by electronic mail September 11~~6~~, 2002, at an increase of \$398,900.25 in the firm fixed price.
2. The contractor, and subcontractor(s) as applicable, shall provide the labor, including, but not limited to, acquisition, installation, activation, sustaining engineering, materials, operations and maintenance of equipment, and on-site support (through November 30, 2004) as necessary to provide a telephone security management system to monitor, detect and restrict use of telephone circuits. This infrastructure upgrade shall include the following:
 - a. Application of a predetermined rule set for each line (DN) which will
 - i. allow the call to proceed,
 - ii. terminate the call or
 - iii. notify the assigned monitoring party by e-mail, pager or other methods, at the option of the Government, of rule violations.
 - b. Record a log of events for later review and assessment
 - c. Monitor and detection of voice calls to determine those that become a data stream, resulting in actions being determined by the rule set
 - d. Differentiation between Fax and Data calls. The Government shall have the ability to designate Class of Service for each line to allow only specific transmissions (i.e., a line designated as a FAX line will allow only FAX type data transmissions, thereby preventing the unplugging of a FAX machine and the plugging in of an unauthorized modem).
 - e. Differentiation between a FAX and data type call. Detect and capture laptops and desktop modems being attached to the analog phones, which are located in every office and facility on KSC, and apply predetermined rule set action when a violation occurs.
3. In accomplishment of this effort, the contractor shall provide the following deliverables:
 - a. SecureLogix ETM 3200 Communications Appliance (2 ea)
 - b. SecureLogix ETM 3200 Single Span License (22 ea)
 - c. SecureLogix ETM Server (1 ea)
 - d. SecureLogix Software (1 ea)
 - e. Miscellaneous Switches, Cables, Connectors, etc as necessary
4. The Contractor shall complete this effort no later than six weeks following contract award.
5. As the result of the Government identifying SecureLogix Corporation as the vendor, the Contractor is released of liability if the SecureLogix Corporation product, COTS (Commercial Off the Shelf), does not perform as advertised.

6. Delivery Order Part II, Item 4 is revised to include the increase of \$398,900.25 for this infrastructure upgrade:
