

1. This modification is to incorporate a sixty (60) calendar day Pilot for the Wireless Hand Held services at Kennedy Space Center at a firm fixed price of \$5,846.00. There will be approximately 30 wireless hand held units (25 BlackBerry 6710 units and 5 Siemens SX56 units) utilized in this Pilot.
2. The effort by the Contractor for this Pilot shall include, but not be limited to, the initial coordination, set-up and integration of the interface of the existing ODIN Exchange servers with the BlackBerry Enterprise Server (BES) and Mobile Airwaves Aqivo Wireless Information (Aqivo) server; assistance with related troubleshooting; operation and maintenance of the BES and Aqivo servers.
3. The necessary interface software, provided by NASA, shall be installed in the ODIN Exchange servers with necessary accounts(s) created to support the functioning of the BES and Aqivo servers. Operation and maintenance of the BES and Aqivo services shall include standard server system support as an institutional IT environment system. User setup for BES and Aqivo service and continuing user maintenance shall be provided by the contractor.
4. All user units, both BlackBerry 6710 and Siemens SX56, will be provided by NASA and distributed to the end user. The contractor will be furnished a listing of the Pilot users prior to implementation of the Pilot.
5. Installation and maintenance of the BES and Aqivo hardware and software systems is not covered by the contractor in this Pilot.
6. The period of performance for this Wireless Hand Held Pilot shall commence April 4, 2003 for a period of sixty (60) calendar days.
7. In consideration of the modification agreed to herein as complete equitable adjustment for the changes set forth, the Contractor hereby releases the Government from any and all liability under this delivery order for further equitable adjustment attributable to such fact or circumstances giving rise to these changes.
8. All other terms and conditions remain unchanged.
