


1. In accordance with Master Contract NAS5-98144, C.7, Technology Refreshment Process, the technology refreshment services referenced below is hereby incorporated into this Delivery Order at a fixed price of \$7,265.31.

2. SWR P203 2FNN 00

The contractor shall provide the labor (including, but not limited to, configuration management, user coordination/scheduling, wiring/cabling and equipment installation) and materials necessary to install (1) 3-meter aluminum mesh C-Band satellite antenna on west side of B1201 to be used to receive Fox News Network as identified in OAO proposal dated July 9, 2002.

- a. The contractor shall perform the following tasks:

- (1) Dig hole and place satellite dish pole and cover with concrete.
- (2) Dig trench from satellite location thru ditch to the Southwest corner of B1201 South.
- (3) Install 1 1/2" schedule 80 PVC conduit from satellite location in the trench that was dug in item (2) above.
- (4) Install 1 1/2" galvanized conduit from the PVC conduit installed in item (3) above up the side of building to provide protection of cable.
- (5) Install (1) 1 1/2" electrical LB at the top of the galvanized conduit into the space above the suspended ceiling in room 107S.
- (6) Install (1) RG6 plenum coax cable from the satellite dish thru new conduit to building the into ceiling to room 119 then fish wall and come under floor to satellite receiver cabinet.
- (7) Mount satellite receiver in cabinet.
- (8) Mount satellite dish on pole and ground to an approved ground.
- (9) Adjust satellite dish to the proper track to receive Fox News.
- (10) Test with OAO video technician once the satellite installation has been installed.

- b. The contractor shall provide the following material:

- (1) 250 FT of plenum RG6 coax cable
- (2) 100 FT of 1 1/2 " schedule 80 PVC conduit
- (3) 10 FT of galvanized 1 1/2" conduit
- (4) 4 each 1 1/2" PVC coupling
- (5) 2 each 1 1/2" sweeping 90 PVC conduit 18"
- (6) 1 each 1 1/2" male adapter to connect galvanized conduit to PVC conduit
- (7) 1 each 1 1/2" aluminum electrical LB
- (8) 1 each C-Band LNB
- (9) 1 each C-Band feedhorn
- (10) 1 each Blonder Tongue commercial IRD with Videocipher II Plus receiver
- (11) 1 each 3-meter aluminum mesh C-Band satellite antenna

- c. Schedule: The completion of this effort shall be (4) four weeks after the receipt of a signed Modification.

- d. The contractor is responsible for the testing and alignment of the satellite antenna and tuning of satellite receiver. The contractor shall integrate the channel into the SSC Video Network and shall become part of the system.
